RULES

2012 STROKE HANDICAP MATCHPLAY INTERCLUB PENNANT

HOME AND AWAY SERIES

ALL PLAY SHALL BE UNDER THE CURRENT ROYAL AND ANCIENT GOLF CLUB OF ST ANDREWS RULES OF GOLF AND LOCAL RULES OF THE HOST CLUB, WHICH SHALL BE IN ACCORDANCE WITH RULE 33-8 [a] AND CONSISTENT WITH THE POLICY SET FORTH IN APPENDIX 1 TO THE RULES:

1. TEAMS TO COMPRISE SIX MALE PLAYERS

HANDICAP LIMIT FOR THE THREE GRADES WILL BE:

- * A GRADE – 0 - 10 AS AT 1/06/12 FOR DIV 2 SECT 2 ALL OTHER DIV'S 1/7/12
- * B GRADE – 11 - 18 AS AT 1/06/12 FOR DIV 2 SECT 2 ALL OTHER DIV'S 1/7/12
- * C GRADE – 19- 36 AS AT 1/06/12 FOR DIV 2 SECT 2 ALL OTHER DIV'S 1/7/12

2. **COMPETITION** –STROKE HANDICAP MATCH PLAY. THE LOWEST HANDICAP PLAYERS IN EACH MATCH RETURNS TO SCRATCH. HIS OPPONENT REDUCES HIS HANDICAP BY THE SAME MARGIN. HOLES WHERE STROKES ARE RECEIVED WILL BE PER GOLF AUSTRALIA APPROVED BALANCED DISTRIBUTION INDEX PROVIDED ON SCORE CARDS AT EACH COURSE OR ISSUED TO TEAM MANAGERS PRIOR TO COMPETITION. PLAYERS MAY PLAY IN ANY HANDICAP ORDER. ALL HANDICAPS WILL BE 1ST JUNE 2012 OR 1ST JULY 2012 AND FROZEN FOR ENTIRE SERIES. **TEAM SHEET TO BE MADE OUT WITH THE No. 1 PLAYER AT BOTTOM PLAYING LAST AND THE No. 6 PLAYER AT THE TOP PLAYING FIRST.**

3. PLAY WILL BE IN FOURS

4. PLAYERS WHO COMPLETED IN THE PENNANT SERIES AND JUNIOR PENNANT SERIES DURING THE YEAR ARE INELIGIBLE FOR THIS INTERCLUB PENNANT SERIES. PENALTY: LOSS OF MATCH – SIX GAMES – NIL. JUNIOR INTERCLUB EXEMPT.

5. PLAYERS MUST BE FINANCIAL MALE MEMBERS [WITH PLAYING RIGHTS] OF THE CLUB FOR WHICH THEY PLAY AND THEY MUST HAVE A CURRENT GOLF AUSTRALIAN HANDICAPS. PENALTY: LOSS OF MATCH SIX GAMES TO NIL.

6. THE HOST CLUB MUST PROVIDE A STARTER TO WHOM THE TEAM MANAGER/CAPTAIN OF EACH TEAM WILL SUBMIT THEIR TEAM IN PLAYING ORDER 10 MINUTES BEFORE THE FIRST PLAYER IS DUE TO HIT OFF. FAILURE TO DO SO WILL RESULT IN THE NUMBER 6 PLAYER OF THE OFFENDING CLUB BEING DEEMED TO HAVE LOST THE FIRST HOLE. THE PLAYING ORDER CANNOT BE CHANGED ONCE THE TEAM SHEET HAS BEEN SUBMITTED. THE HOST CLUB WILL BE RESPONSIBLE FOR THE COLLECTION AND RETURN OF THE COMPLETED RESULT SHEETS TO THE SECRETARY OF THE GCDGA ON THE DAY OF THE MATCH.

6a IF ANY TEAM FAILS TO SUBMIT A TEAM SHEET WITHIN 30 MINUTES AFTER THE FIRST PLAYER IS DUE TO HIT OFF THEN THAT TEAM WILL BE FORCED TO FORFEIT ALL SCHEDULED MATCHES.

IF THE HOST CLUB STARTER RECEIVES ADVICE FROM ANY CLUB THAT FOR REASONS BEYOND THEIR CONTROL THE ENTIRE TEAM WILL BE LATE THEN THE STARTER HAS THE OPTION OF RE-SCHEDULING THEIR MATCH TIMES WITHOUT PENALTY. THE HOST CLUB WILL BE RESPONSIBLE FOR THE COLLECTION AND RETURN OF THE COMPLETED RESULT SHEETS TO THE SECRETARY OF THE GCDGA ON THE DAY OF THE MATCH.

7. THE FIRST INDIVIDUAL MATCH OF THE PENNANT FIXTURE SHALL BE READY TO HIT OFF AT THE APPOINTED TIME. A PLAYER SHALL BE CONSIDERED ABSENT IF HE IS NOT READY TO PLAY AT THE TIME HIS INDIVIDUAL MATCH IS DUE TO HIT OFF. THE RESERVE PLAYER MUST THEN SUBSTITUTE FOR THE ABSENT PLAYER. FAILURE TO COMPLY WITH THIS RULE AWARDS A WIN TO THE OPPOSING TEAM FOR THAT INDIVIDUAL MATCH.

8. MOTORIZED CARTS ARE PERMITTED.
9. PLAYERS MUST NOT CONTINUE TO PLAY ONCE THEIR INDIVIDUAL MATCH HAS BEEN COMPLETED.
10. THE HOME CLUBS ARE NOT REQUIRED TO SUPPLY MOTORIZED CARTS FREE OF CHARGE TO VISITING TEAM PLAYERS OR OFFICIALS.

CONDITIONS OF PLAY

2012 STROKE HANDICAP MATCH PLAY INTERCLUB SERIES

ALL CLUBS WILL BE INVITED BY THE GOLD COAST DISTRICT GOLF ASSOCIATION TO SUBMIT INTERCLUB TEAMS FOR THE 3 GRADES. IF THE INVITATION IS ACCEPTED, THE CLUBS ARE BOUND BY THE FOLLOWING CONDITIONS:

- A** \$12.00 NOMINATION FEE WILL BE CHARGED FOR EACH TEAM.
- B** NO SOCIAL OR COMPETITION PLAY IS PERMITTED WITHIN 20 MINUTES OF THE START OF THE INTERCLUB MATCHES.
- C** THE COURSE IS TO BE PREPARED TO THE SATISFACTION OF THE GCDGA MANAGEMENT COMMITTEE. PLAY IS TO BE FROM THE BLUE OR CHAMPIONSHIP MARKERS FOR "A" GRADE AND THE WHITE OR FORWARD MARKERS FOR "B" & "C" GRADES [UNLESS ADVISED DIFFERENTLY BY THE GCDGA MANAGEMENT COMMITTEE]. THE COMPETITION WILL BE PLAYED ON SUNDAY WITH THE COMMENCEMENT OF PLAY AT TIMES AS SET DOWN ON THE OFFICIAL DRAW ON DATES TO BE FIXED BY THE GCDGA MANAGEMENT COMMITTEE.
- D** [1] A WIN BETWEEN TEAMS SHALL BE SECURED BY THE TEAM WINNING THE GREATER NUMBER OF INDIVIDUAL MATCHES AND SUCH TEAM WILL RECEIVE 2 POINTS. IF THE NUMBER OF INDIVIDUAL MATCHES WON IS EQUAL, TEAMS WILL RECEIVE ONE POINT EACH, INDIVIDUAL MATCH TIED AFTER 18 HOLES SHALL BE HALVED.
- [2] THE TWO LEADING TEAMS OF A, B & C GRADES IN EACH DIVISION WILL PLAY OFF FOR THE PENNANT ON A DATE AND VENUE TO BE DECIDED BY THE GCDGA MANAGEMENT COMMITTEE.
- [3] IN THE EVENT OF TWO OR MORE TEAMS BEING EQUAL ON POINTS AFTER THE COMPLETION OF THE PRELIMINARY ROUNDS THE TWO FINALISTS WILL BE DECIDED BY THE TEAM WITH THE GREATER NUMBER OF INDIVIDUAL MATCHES WON OR HALVED. IF A TIE STILL EXISTS, THEN THE TEAMS WITH THE GREATER NET WINNING MARGINS DURING THE SERIES SHALL BE DECLARED THE FINALISTS WITH THE PROVISION THAT IF THERE IS A FORFEIT IN ANY INDIVIDUAL MATCH THEN THE TEAM RECEIVING THE FORFEIT WILL BE ALLOCATED A 3/0 WIN. IF A TIE STILL EXISTS THE TEAMS SHALL PLAY OFF ON A DATE AND COURSE SET BY THE GCDGA MANAGEMENT COMMITTEE.
- [4] IN THE EVENT OF A TIED MATCH IN THE FINAL OF THIS COMPETITION THE PENNANT WILL BE AWARDED TO THE TEAM WHO FINISHED ON TOP OF THE HOME & AWAY TABLE AFTER ALL PRELIMINARY MATCHES WERE COMPLETED.
- [5] IN "A" GRADE ONLY THE TWO FINALISTS OF DIVISION 2 WILL BE PROMOTED TO DIVISION 1 FOR THE FOLLOWING YEAR AND THE BOTTOM TWO TEAMS IN DIVISION 1 WILL BE RELEGATED TO DIVISION 2 FOR THE FOLLOWING YEAR.
- E** IN THE EVENT OF A MATCH BEING CANCELLED DUE TO A COURSE BEING UNPLAYABLE, ALL INDIVIDUAL MATCHES COMPLETED, PARTIALLY COMPLETED OR NOT STARTED AT ALL ON THE SAME COURSE WILL BE CANCELLED. EACH TEAM WILL RECEIVE 1 POINT AND 3 GAMES AND ANY TEAM THAT HAS A BYE WILL NOT RECEIVE ANY POINTS OR GAMES.
- F** THE MATCH COMMITTEE OF THE HOST CLUB SHALL BE THE RULING BODY AND ANY DECISION MADE BY THEM SHALL BE FINAL. ANY MEMBER OF THE GCDGA MANAGEMENT COMMITTEE MAY GIVE ASSISTANCE WITH RULINGS.

- G** PRACTICE BEFORE A MATCH SHALL BE LIMITED TO:
[1] PRACTICE PUTTING GREEN
[2] PRACTICE FAIRWAY
- H** THE GCDGA MANAGEMENT COMMITTEE MAY VARY CONDITIONS OF PLAY AS DEEMED NECESSARY.
- I** PLAYERS/CADDIES AND TEAM OFFICIALS MUST CONFORM TO THE DRESS REGULATIONS AND BEHAVIOUR STANDARDS OF THE HOST CLUB. THE TEAM MANAGER IS RESPONSIBLE FOR THE SPEED OF PLAY AND CONDUCT OF THEIR TEAM.
- J** PLAYERS, CADDIES AND OR CLUB OFFICIALS ARE ADVISED THAT THE USE OR RINGING OF MOBILE PHONES ARE RESTRICTED TO CARPARK AND CLUB HOUSE ONLY AT EACH CLUB/VENUE UNLESS A MEDICAL EMERGENCY ARISES. [ALL PHONES MUST BE TURNED OFF OR PLACED ON SILENT MODE DURING ANY COMPETITION ROUND]. PENALTY: LOSS OF HOLE WHERE INFRINGEMENT OCCURRED – HOWEVER ANY FURTHER OFFENCES DURING THE SAME GAME COULD RESULT IN THE PLAYER BEING DISQUALIFIED.
- K** PLAYERS ARE ADVISED THAT THE G.C.D.G.A. WILL ALLOW THE USE OF ARTIFICIAL DEVICES THAT MEASURE OR GAUGE DISTANCES ONLY IN THIS COMPETION.
- L** ALCOHOL MUST NOT BE CONSUMED ON THE GOLF COURSE DURING ANY G.C.D.G.A. EVENT. PLAYERS MAY FACE IMMEDIATE DISQUALIFICATION AND BE ASKED TO LEAVE THE COURSE.
- M** EACH CLUB, WITH A TEAM PLAYING ON THE DAY SHOULD PROVIDE A TEAM MANAGER/CAPTAIN WHO WILL BE RESPONSIBLE FOR THE DRESS STANDARD, BEHAVIOUR, AND SPEED OF PLAY OF THEIR TEAM MEMBERS. THE TEAM MANAGER/CAPTAIN MUST ALSO ENSURE THAT THEIR PLAYERS DO NOT CONTINUE PLAY ONCE THEIR INDIVIDUAL MATCH HAS BEEN COMPLETED. THE NAME OF THE TEAM MANAGER/CAPTAIN MUST APPEAR ON THE TEAM SHEET FOR THE DAY IN THE APPROPRIATE POSITION.
- N** TO BE ELIGIBLE TO PLAY IN THE FINAL A PLAYER MUST PLAY IN AT LEAST ONE PRELIMINARY ROUND DURING THE SEASON. THE GCDGA MAY UNDER SPECIAL CIRCUMSTANCES WAIVER THIS RULE IF NECESSARY.
- O** N.B: ALL CLUBS WHO PLAY ROUNDS AT BOTH SANCTUARY COVE AND LINKS HOPE ISLAND ARE REQUIRED TO USE MOTORISED GOLF CARTS. A NOMINAL CHARGE FOR THESE CARTS IS CHARGED AND VISITING CLUBS SHOULD CONTACT THESE CLUBS PRIOR TO PLAYING.
- p** ANY CLUB THAT DOES NOT ABIDE BY THESE CONDITIONS MAY HAVE THEIR NOMINATION REJECTED FOR THE NEXT SEASON.
- Q** AS ALL VENUES FOR THIS COMPETITION FINALS ARE BOOKED 12 MONTHS IN ADVANCE, THE G.C.D.G.A. MANAGEMENT COMMITTEE RESERVES THE RIGHT TO TRANSFER ANY MATCH TO A NEUTRAL VENUE WHERE POSSIBLE TO ENSURE THE HOST CLUB FAILS TO GAIN ANY HOME COURSE ADVANTAGE IN THEIR PARTICULAR FINAL.
