## **THE JOHN GOSS SHIELD 2012 SENIOR PENNANT RULES**

ALL PLAY SHALL BE UNDER THE CURRENT ROYAL AND ANCIENT GOLF CLUB OF ST ANDREWS RULES OF GOLF AND LOCAL RULES OF THE HOST CLUB, WHICH SHALL BE IN ACCORDANCE WITH RULE 33-8 [a] AND CONSISTENT WITH THE POLICY SET FORTH IN APPENDIX 1 TO THE RULES:

1. TEAMS TO COMPRISE **6 MALE PLAYERS**. **IN FINAL MATCHES TEAMS TO COMPRISE 7 MALE PLAYERS** THERE WILL BE NO HANDICAP LIMITS.
2. COMPETITION – STROKE MATCH PLAY. PLAYERS MAY PLAY IN ANY ORDER. TEAM SHEET IS TO BE MADE OUT WITH NO.1 PLAYERS AT THE BOTTOM PLAYING LAST AND THE NO.6 PLAYERS AT THE TOP PLAYING FIRST.
3. PLAY WILL BE IN FOURS [EACH FOUR TO BE MADE UP OF TWO PLAYERS FROM EACH CLUB PLAYING IN THE SCHEDULED MATCH] MOTORISED BUGGIES ARE ALLOWED.
4. ALL PLAY TO BE **“OFF THE STICK”**
5. ALL PLAYERS MUST BE 50 YEARS OF AGE OR OVER PRIOR TO THE COMMENCEMENT OF THE FIRST ROUND AND THEY MAY ONLY REPRESENT ONE CLUB IN ANY ONE SENIOR PENNANT SEASON. THEY MUST BE FINANCIAL MALE MEMBERS [WITH PLAYING RIGHTS] OF THE CLUB FOR WHICH THEY PLAY AND THEY MUST HAVE A CURRENT AUSTRALIAN HANDICAP. [PENALTY – LOSS OF MATCH 6 -0]
6. THE HOST CLUB MUST PROVIDE A STARTER TO WHOM THE TEAM MANAGER/CAPTAIN OF EACH TEAM WILL SUBMIT THEIR TEAM IN PLAYING ORDER 10 MINUTES BEFORE THE FIRST PLAYER IS DUE TO HIT OFF. FAILURE TO DO SO WILL RESULT IN THE NUMBER 6 PLAYER OF THE OFFENDING CLUB BEING DEEMED TO HAVE LOST THE FIRST HOLE. THE PLAYING ORDER CANNOT BE CHANGED ONCE THE TEAM SHEET HAS BEEN SUBMITTED.  
  
**6a.** IF ANY TEAM FAILS TO SUBMIT A TEAM SHEET WITHIN 30 MINUTES AFTER THE FIRST PLAYER IS DUE TO HIT OFF THEN THAT TEAM WILL BE FORCED TO FORFEIT ALL SCHEDULED MATCHES.  
IF THE HOST CLUB STARTER RECEIVES ADVICE FROM ANY CLUB THAT FOR REASONS BEYOND THEIR CONTROL THE ENTIRE TEAM WILL BE LATE THEN THE STARTER HAS THE OPTION OF RE-SCHEDULING THEIR MATCH TIMES WITHOUT PENALTY. THE HOST CLUB WILL BE RESPONSIBLE FOR THE COLLECTION AND RETURN OF THE COMPLETED RESULT SHEETS TO THE SECRETARY OF THE GCDGA ON THE DAY OF THE MATCH.
7. THE FIRST INDIVIDUAL MATCH OF THE PENNANT FIXTURE SHALL BE READY TO HIT OFF AT THE APPOINTED TIME. A PLAYER SHALL BE CONSIDERED ABSENT IF HE IS NOT READY TO PLAY AT THE TIME HIS INDIVIDUAL MATCH IS DUE TO HIT OFF. THE RESERVE PLAYER MUST THEN SUBSTITUTE FOR THE ABSENT PLAYER. FAILURE TO COMPLY WITH THIS RULE AWARDS A WIN TO THE OPPOSING TEAM FOR THAT INDIVIDUAL MATCH.
8. THE HOME CLUBS ARE NOT REQUIRED TO SUPPLY MOTORISED CARTS FREE OF CHARGE TO VISITING TEAM PLAYERS OR OFFICIALS.

### **2012 SUPER SENIOR PENNANT**

## **RULES**

ALL PLAY SHALL BE UNDER THE CURRENT ROYAL AND ANCIENT GOLF CLUB OF ST ANDREWS RULES OF GOLF AND LOCAL RULES OF THE HOST CLUB, WHICH SHALL BE IN ACCORDANCE WITH RULE 33-8 [a] AND CONSISTENT WITH THE POLICY SET FORTH IN APPENDIX 1 TO THE RULES:

1. **TEAMS TO COMPRISE 6 MALE PLAYERS. IN FINAL MATCHES TEAMS TO COMPRISE 7 MALE PLAYERS THERE WILL BE NO HANDICAP LIMITS.**
2. **COMPETITION –STROKE HANDICAP MATCH PLAY. THE LOWEST PLAYER IN EACH MATCH RETURNS TO SCRATCH. HIS OPPONENT REDUCES HIS HANDICAP BY THE SAME MARGIN. HOLES WHERE STROKES ARE RECEIVED WILL BE PER GOLF AUSTRALIA APPROVED BALANCED DISTRIBUTION INDEX PROVIDED TO EACH TEAM MANAGER ON ALL COURSES PLAYED IN THE SERIES. [PLAYERS MAY PLAY IN ANY HANDICAP ORDER] ALL HANDICAPS WILL BE AS AT THE 1<sup>ST</sup> ROUND AND BE FROZEN FOR ENTIRE SERIES. TEAM SHEET TO BE MADE OUT WITH THE No. 1 PLAYER AT THE BOTTOM PLAYING LAST AND THE No. 6 PLAYER AT THE TOP PLAYING FIRST.**
3. **PLAY WILL BE IN FOURS [EACH FOUR TO BE MADE UP OF TWO PLAYERS FROM EACH CLUB PLAYING IN THE SCHEDULED MATCH] MOTORISED BUGGIES ARE ALLOWED.**
4. **ALL PLAYERS MUST BE 60 YEARS OF AGE OR OVER PRIOR TO THE COMMENCEMENT OF THE FIRST ROUND AND THEY MAY ONLY REPRESENT ONE CLUB IN ANY ONE SENIOR PENNANT SEASON. THEY MUST BE FINANCIAL MALE MEMBERS [WITH PLAYING RIGHTS] OF THE CLUB FOR WHICH THEY PLAY AND THEY MUST HAVE A CURRENT AUSTRALIAN HANDICAP. [PENALTY – LOSS OF MATCH SIX GAMES TO NIL]**
5. **THE HOST CLUB MUST PROVIDE A STARTER TO WHOM THE TEAM MANAGER/CAPTAIN OF EACH TEAM WILL SUBMIT THEIR TEAM IN PLAYING ORDER 10 MINUTES BEFORE THE FIRST PLAYER IS DUE TO HIT OFF. FAILURE TO DO SO WILL RESULT IN THE NUMBER 7 PLAYER OF THE OFFENDING CLUB BEING DEEMED TO HAVE LOST THE FIRST HOLE. THE PLAYING ORDER CANNOT BE CHANGED ONCE THE TEAM SHEET HAS BEEN SUBMITTED.**
6. **THE FIRST INDIVIDUAL MATCH OF THE PENNANT FIXTURE SHALL BE READY TO HIT OFF AT THE APPOINTED TIME. A PLAYER SHALL BE CONSIDERED ABSENT IF HE IS NOT READY TO PLAY AT THE TIME HIS INDIVIDUAL MATCH IS DUE TO HIT OFF. THE RESERVE PLAYER MUST THEN SUBSTITUTE FOR THE ABSENT PLAYER. FAILURE TO COMPLY WITH THIS RULE AWARDS A WIN TO THE OPPOSING TEAM FOR THAT INDIVIDUAL MATCH.**  
**6a. IF ANY TEAM FAILS TO SUBMIT A TEAM SHEET WITHIN 30 MINUTES AFTER THE FIRST PLAYER IS DUE TO HIT OFF THEN THAT TEAM WILL BE FORCED TO FORFEIT ALL SCHEDULED MATCHES.**  
**IF THE HOST CLUB STARTER RECEIVES ADVICE FROM ANY CLUB THAT FOR REASONS BEYOND THEIR CONTROL THE ENTIRE TEAM WILL BE LATE THEN THE STARTER HAS THE OPTION OF RE-SCHEDULING THEIR MATCH TIMES WITHOUT PENALTY. THE HOST CLUB WILL BE RESPONSIBLE FOR THE COLLECTION AND RETURN OF THE COMPLETED RESULT SHEETS TO THE SECRETARY OF THE GCDGA ON THE DAY OF THE MATCH.**
7. **PLAYERS MUST NOT CONTINUE TO PLAY ONCE THEIR INDIVIDUAL MATCH HAS BEEN COMPLETED.**
8. **THE HOME CLUBS ARE NOT REQUIRED TO SUPPLY MOTORISED CARTS FREE OF CHARGE TO TEAM OFFICIALS.**

ALL CLUBS WILL BE INVITED BY THE GOLD COAST DISTRICT GOLF ASSOCIATION TO SUBMIT A PENNANT TEAM. IF THE INVITATION IS ACCEPTED, THE CLUBS ARE BOUND BY THE FOLLOWING CONDITIONS:

- A A \$12.00 NOMINATION FEE WILL BE CHARGED FOR EACH TEAM.
- B NO SOCIAL OR COMPETITION PLAY IS PERMITTED WITHIN 20 MINUTES OF THE START OF THE SENIOR & SUPER SENIOR PENNANT MATCHES.
- C [1] THE COURSE IS TO BE PREPARED TO THE SATISFACTION OF THE GCDGA MANAGEMENT COMMITTEE.
- [2] IN SENIOR PENNANT - ALL PLAY WILL BE FROM THE BLUE MARKERS.
- [3] IN SUPER SENIOR PENNANT - ALL PLAY WILL BE FROM THE WHITE MARKERS. THE HOST CLUB HAS THE DISCRETION TO ALTER THE TEES IF CONSIDERED NECESSARY. THE COMPETITION WILL BE PLAYED ON MONDAYS WITH THE COMMENCEMENT OF PLAY BETWEEN 7.00AM AND 12.00 NOON ON DATES TO BE FIXED BY THE GCDGA MANAGEMENT COMMITTEE.
- D [1] A WIN BETWEEN TEAMS SHALL BE SECURED BY THE TEAM WINNING THE GREATER NUMBER OF INDIVIDUAL MATCHES AND SUCH TEAM WILL RECEIVE 2 POINTS. IF THE NUMBER OF INDIVIDUAL MATCHES WON IS EQUAL, TEAMS WILL RECEIVE ONE POINT EACH, INDIVIDUAL MATCHES TIED AFTER 18 HOLES SHALL BE HALVED.
- [2] IN SENIOR PENNANT THE TWO LEADING TEAMS IN EACH DIVISION WILL PLAY OFF FOR THE PENNANT ON A DATE AND VENUE TO BE DECIDED BY THE GCDGA MANAGEMENT COMMITTEE. THE WINNER OF DIVISION 2 WILL BE PROMOTED TO DIVISION 1 FOR THE FOLLOWING YEAR AND THE BOTTOM TEAM IN DIVISION 1 WILL BE RELEGATED TO DIVISION 2.
- [3] IN SUPER SENIOR PENNANT THE TWO LEADING TEAMS IN EACH DIVISION WILL PLAY OFF FOR THE PENNANT ON A DATE AND VENUE TO BE DECIDED BY THE GCDGA MANAGEMENT COMMITTEE. THE WINNER OF DIVISION 2 WILL BE PROMOTED TO DIVISION 1 FOR THE FOLLOWING YEAR AND THE BOTTOM TEAM IN DIVISION 1 WILL BE RELEGATED TO DIVISION 2.
- [4] IN THE EVENT OF TWO OR MORE TEAMS BEING EQUAL ON POINTS AFTER THE COMPLETION OF THE PRELIMINARY ROUNDS THE TWO FINALISTS WILL BE DECIDED BY THE TEAM WITH THE GREATER NUMBER OF INDIVIDUAL MATCHES WON OR HALVED. IF A TIE STILL EXISTS, THEN THE TEAMS WITH THE GREATER NET WINNING MARGINS DURING THE SERIES SHALL BE DECLARED THE FINALISTS WITH THE PROVISION THAT IF THERE IS A FORFEIT IN ANY INDIVIDUAL MATCH THEN THE TEAM RECEIVING THE FORFEIT WILL BE ALLOCATED A 3/0 WIN. IF A TIE STILL EXISTS THE TEAMS SHALL PLAY OFF ON A DATE AND COURSE SET BY THE GCDGA MANAGEMENT COMMITTEE.
- [5] AFTER THE COMPLETION OF ALL PRELIMINARY ROUNDS OF BOTH SENIORS AND SUPER SENIORS PENNANT COMPETITIONS THE TWO LEADING TEAMS WILL PLAY OFF IN A FINAL TO DETERMINE THE WINNER OF THE SENIORS AND SUPER SENIORS PENNANT. EACH MATCH WILL BE PLAYED ON A COURSE AND AT A TIME WHICH WILL BE DECIDED BY THE G.C.D.G.A MATCH COMMITTEE. IN EACH FINAL ALL INDIVIDUAL MATCHES WILL BE PLAYED OUT SO THAT A CLEAR WINNER OF ALL SENIORS PENNANT IS DECIDED. TO ENABLE A DEFINITIVE RESULT IN SENIOR AND SUPER SENIORS PENNANT THE FINAL WILL COMPRISE TWO TEAMS OF SEVEN PLAYERS ONE MORE PLAYER THAN IN THE PRELIMINARY ROUNDS. IN THE EVENT OF A RESULT BEING ACHIEVED REMAINING INDIVIDUAL MATCHES ON THE COURSE WILL THEN END ON THE 18<sup>TH</sup> GREEN.
- E IN THE EVENT OF A MATCH BEING CANCELLED DUE TO A COURSE BEING UNPLAYABLE, ALL INDIVIDUAL MATCHES COMPLETED, PARTIALLY COMPLETED OR NOT STARTED AT ALL ON THE

SAME COURSE SHALL BE CANCELLED. EACH TEAM WILL RECEIVE 1 POINT AND 3 INDIVIDUAL MATCHES AND ANY TEAM THAT HAS A BYE WILL NOT RECEIVE ANY POINTS OR MATCHES.

- F [1] PRACTICE ROUNDS  
NO CLUB IS REQUIRED TO PROVIDE FREE OF CHARGE PRACTICE ROUNDS ON THEIR COURSE PRIOR TO ANY COMPETITION MATCH. ANY ARRANGEMENT FOR PRACTICE ROUNDS MUST BE BY AGREEMENT BETWEEN BOTH CLUB CAPTAINS ONLY. PLAYERS MUST NOT APPROACH CLUBS FOR PRACTICE ROUNDS AT ANY TIME.
- [2] PRACTICE ON MATCH DAY SHALL BE LIMITED TO:  
[1] PRACTICE PUTTING GREEN  
[2] PRACTICE FAIRWAY
- G THE GCDGA MANAGEMENT COMMITTEE MAY VARY CONDITIONS OF PLAY AS DEEMED NECESSARY.
- H PLAYERS/CADDIES AND TEAM OFFICIALS MUST CONFORM TO THE DRESS REGULATIONS AND BEHAVIOUR STANDARDS OF THE HOST CLUB. THE TEAM MANAGER IS RESPONSIBLE FOR THE SPEED OF PLAY AND CONDUCT OF THEIR TEAM.
- I PLAYERS ARE ADVISED THAT THE G.C.D.G.A. WILL ALLOW THE USE OF ARTIFICIAL DEVICES THAT MEASURE OR GAUGE DISTANCES ONLY IN THIS COMPETION.
- J PLAYERS, CADDIES AND OR CLUB OFFICIALS ARE ADVISED THAT THE USE OR RINGING OF MOBILE PHONES ARE RESTRICTED TO CARPARK AND CLUB HOUSE ONLY AT EACH CLUB/VENUE UNLESS A MEDICAL EMERGENCY ARISES. [ALL PHONES MUST BE TURNED OFF OR PLACED ON SILENT MODE DURING ANY COMPETITION ROUND]. PENALTY: LOSS OF HOLE WHERE INFRINGEMENT OCCURRED – HOWEVER ANY FURTHER OFFENCES DURING THE SAME INDIVIDUAL MATCH COULD RESULT IN THE PLAYER BEING DISQUALIFIED.
- K EACH HOST CLUB **MUST** PROVIDE A STARTER FOR THE ROUND PLAYED AT THEIR CLUB AND **MUST** PROVIDE A MATCH COMMITTEE FOR THE DAY TO ASSIST WITH RULINGS OR ANY QUERIES OF THE RULES OF GOLF AND THE CLUB LOCAL RULES, AND TO COMPILE THE RESULTS OF THE MATCHES OF THE DAY.
- L THE MATCH COMMITTEE SHALL BE THE RULING BODY AND ANY DECISION MADE BY THEM SHALL BE FINAL. ANY MEMBER OF THE GCDGA MANAGEMENT COMMITTEE MAY GIVE ASSISTANCE WITH RULINGS.
- M EACH CLUB WITH A TEAM PLAYING ON THE DAY MUST PROVIDE A TEAM MANAGER/CAPTAIN WHO WILL BE RESPONSIBLE FOR THE DRESS STANDARD, BEHAVIOUR, AND SPEED OF PLAY OF THEIR TEAM MEMBERS. THE TEAM MANAGER/CAPTAIN MUST ALSO ENSURE THAT THEIR PLAYERS DO NOT CONTINUE PLAY ONCE A INDIVIDUAL MATCH HAS BEEN COMPLETED. THE NAME OF THE TEAM MANAGER/CAPTAIN MUST APPEAR ON THE TEAM SHEET FOR THE DAY IN THE APPROPRIATE POSITION.
- N TO BE ELIGIBLE TO PLAY IN THE FINAL A PLAYER MUST PLAY IN AT LEAST ONE PRELIMINARY ROUND DURING THE SEASON. THE GCDGA MAY UNDER SPECIAL CIRCUMSTANCES WAIVER THIS RULE IN NECESSARY.
- O N.B: ALL CLUBS WHO PLAY ROUNDS AT BOTH SANCTUARY COVE AND LINKS HOPE ISLAND ARE REQUIRED TO USE MOTORISED GOLF CARTS. A NOMINAL CHARGE FOR THESE CARTS IS CHARGED AND VISITING CLUBS SHOULD CONTACT THESE CLUBS PRIOR TO PLAYING.
- P ANY CLUB THAT DOES NOT ABIDE BY THESE CONDITIONS MAY HAVE THEIR NOMINATION REJECTED FOR THE NEXT SEASON.
